POL-6966	6.2	Leap: Holds to Transfer view of the Picklist is once again showing holds that need to be transferred when changing the pickup branch via Leap.	
POL-5940	6.2	Leap: Items created via templates that include library assigned blocks no longer throw an error when changing the assigned branch.	
POL-6990	6.2	Leap: Loanable Outside System option is no longer checked for new items created in Leap when the option is not checked in the item template that is used to create the item.

POL-2558	6.2	Leap: Patron registration dates including expiration, address check and registration date are now based on server time, rather than client time. This is consistent with the Polaris staff client.

POL-6610	6.2	Leap: The "Exceeded material type request limit" message no longer displays when the request is reactivated from the Request Manager, and the request is then reactivated.

POL-2655	6.2	Leap: The patron registration record is now only locked when it is open.	

POL-6828	6.2	Leap: The patron statistical class is once again visible in the patron record in Leap.	
POL-5868	6.2	Leap: When copying the patron registration, and then changing the assigned branch prior to a save, the copied info now sticks instead of reverting to the originally copied patron info.	
POL-6797	6.2	Leap: In order to maintain consistent date/times, all date/time fields in Leap have been updated to always use the date/time value from the Server.	
POL-6780	6.2	Leap: Patron barcodes are now considered case sensitive for purposes of patron duplicate detection.	
POL-6906	6.2	Notices: When the second overdue notice is sent via text, it no longer appears on the Summary report as '1st overdue txt notice sent to'.	
POL-6808	6.2	PAC: Searches containing an asterisk wildcard can fail. This issue is solved by adding a Recompile hint to the registry. Recompile hint is disabled by default. It can be enabled by setting the "EnableRecompileHint" DWORD value located in the "Computer\HKEY_LOCAL_MACHINE\SYSTEM\CurrentControlSet\Services\ERMSDaemon.6.2\Parameters" key to 1. After updating this value, you must restart ERMSDaemon.

POL-4216	6.2	PAC: If you navigate to a saved list or working list in the Power PAC's Identify String function in WebAdmin, the HTML tag and the language string no longer show for several of the buttons.	9891283

Now, when placing a hold request from PAC, the option to set Activation Date will not be there (existing feature based on the SA setting). When affecting an existing request, the Suspend/Reactivate button shall be suppressed based on the SA setting. If patrons have existing holds that are inactive, eventually they will become active (when the expiration date arrives) or they can call the library to activate their requests.	6527230
