POL-6312	6.1	Circulation (INN-Reach): When a borrowing library checked out an INN-Reach ILL item to an associated patron, the hold processing remained incomplete. Now the hold is updated with the correct (associated) patron information at check-out.	
POL-1772	6.1	ExpressCheck: ExpressCheck will display a held item as "Routing to: " with no branch specified even if the item is Held and on the shelf at the pickup location. This has been fixed.	6527222
POL-6427	6.1	Holds: Requests not always going to secondary when there are no available items in primary. This has been fixed.	
POL-2750	6.1	Holds: Under specific circumstances, the Hold Request ID logged in the 6001 transaction was incorrect. This has been fixed.	6527277
POL-6335	6.1	INN-Reach (Circ): A Polaris library borrowed an item from another library via INN-Reach. The item was received at a central branch part of the Borrowing Polaris Library. The item then went In-Transit to the pickup branch. However, the item was then checked back into the Lending Library without the Borrowing Polaris Library having ever checked the item in at the pick up location. The item was marked as In-Transit within Polaris at the time the Lending Library sent a 'Final Item Check-In' message to the borrowing library. As such, Polaris was not able to properly handle the deletion and clean-up of the INN-Reach request. This out-of-sequence workflow has now been addressed by the Polaris software.
